RESOLUTION NO. 8634

**A RESOLUTION AUTHORIZING THE CREATION OF
TOBACCO-FREE ZONES IN THE CITY OF WATERVLIET**

WHEREAS, the Capital District Tobacco-Free Coalition, with an address of 24 Aviation Road, Suite 204, Albany, New York 12205, has provided information to the City Council of the following:

(1) Smoking is responsible for premature deaths of over 440,000 Americans each year from lung cancer, heart disease, respiratory illness and other diseases.

(2) Secondhand smoke is responsible for over 50,000 deaths among nonsmokers each year.

(3) Tobacco kills more Americans each year than alcohol, cocaine, crack, heroin, homicide, suicide, accidents, fires, and AIDS combined.

(4) 80% of smokers started smoking before the age of 18 and the average initiation age is 12 years old.

(5) Everyday an estimated 3,900 young people under the age of 18 try their first cigarette and one-third of these children will die prematurely from tobacco related illnesses.

(6) That cities, towns, and villages in the State of New York can help role model non-smoking behavior to children and youth by providing children, youth, and their families with a safe, smoke-free environment.

WHEREAS, the City Council of the City of Watervliet finds and determines that the creation of tobacco-free zones in the City of Watervliet will promote the healthy, safety, and well being of all residents of the City of Watervliet, including children, youths, and their families.

NOW THEREFORE BE IT RESOLVED THAT:

1. The City Council of the City of Watervliet hereby authorizes and designates the following areas in the City of Watervliet as tobacco-free zones:
 - (a) Brotherhood Park, 25th Street and Sixth Avenue
 - (b) Clinton Park, Clinton Street and Eighth Avenue
 - (c) Seventh Street Park, Seventh Street and First Avenue
 - (d) Red's Field, Eighth Street and Fourth Avenue
 - (e) Eighth Street Basketball Court, Eighth Street and Third Avenue
 - (f) Elks Park, Sixth Street and Third Avenue
 - (g) Memorial Park, Fifteenth Street and Second Avenue
 - (h) Veteran's Recreational Facility, Thirteenth Street and Second Avenue
 - (i) Pershing Green, Fourth Street and Second Avenue
 - (j) Hudson Shores Park

2. The City Council of the City of Watervliet hereby authorizes the Commission of Public Safety and/or his designee to post appropriate signage in the designated tobacco-free zones; and
3. This Resolution shall take effect immediately.
